  Apology can be a powerful turning point in any mediation. In this workshop mediators will discuss the theory and use of apology in mediation. Topics include the definition of apology and forgiveness; the elements of an apology; and the use of apology in mediation and the mediator's role in facilitating that apology. Participants will have an opportunity to role play a variety of apology settings.

Working with attorneys in mediation can be a challenge. Through discussion and shared experiences with non-attorney and attorney mediators, attendees will explore concerns about working with attorneys in mediation; discuss expectations from both the mediators' and attorneys' perspective; develop a "check list" for educating and preparing an attorney and their client for mediation; and strategize about how to handle power imbalances and attorney behaviors during the mediation session. Attorney and Mediator Betty Russo, Esq., will join us and add her perspective to the conversation.

Family mediators often ask for help with various child support issues and calculations. You can learn about the basics of child support that might be helpful to you personally.

How does a client's perception of a mediator's action during a session effect the quality of the mediation process? What do we need to do to ensure an impartial and quality process? Using the Impartiality and Quality of Standards sections of the Standards of Ethics and Professional Responsibility for Certified Mediators, participants will discuss updated in-person and on-line mediation situations as well as mediator practices where the potential for "misperception" might become a factor for the quality of the process.
